1 Rate of Daily Allowance for Employees:-

(1) The rate of Daily Allowance shall be as under-

The rates for Hotel accomodation shall be as per the Haryana Government rules subject to the production of actual payees receipt of Hotel/Bungalow rent etc. However in that case of half daily allowance shall be admissible. No Hotel expenses will be paid for stau within the state.

2 Entitlement for DA:-

(i) Where absense from headquarter is less than 6 hours : 30% of Daily Allowance

(ii) Where absense from headquarter is 6 hours or more but less than 12 hours

: Half Daily Allowance

- (iii) Where absense is for more than 12 hours : Full Daily Allowance
- (iv) No daily allowance shall be paid for a Journey performed within a radius of 8 km.from Headquarter.

3 Entitlement for TA:-

- (i) Employees on sanction posts under Grade-I,II,III are entitled to travel by own car/ Taxi and have mileage entitlement @ Rs. 16/- km. (with prior permission)
- (ii) The lecturers from Management Fund will not be entitled to travel by Taxi or own car. They will be paid deluxe bus fare subject to production of tickets. In case of train, they will be entitled for 3rd A.C.

- (i) Rs. 120/- per day for Sports, Full D.A.
- (ii) Rs. 100/- per day for Cultural Activities and others, Full D.A.
